Auction of the year. Requirements and Regulations

By the submission of a lot (lots) to NSSS for auction on May 23, 1992, the owner indicates total acceptance of these Requirements and Regulations.

By the submission of a bid, buyers indicate total acceptance of these Requirements and Regulations.

- 1. Owners may submit no more than ten auction lots each. All lots must be mounted on pages supplied by NSSS.
- 2. All lots must have minimum bids supplied and shown by owner.
- 3. Owner assumes total responsibility for the safety and handling of their individual lots. Neither NSSS nor its individual members have any responsibility to the owner except for the forwarding of 90% of the hammer price to him.
- 4. NSSS will retain 10% as a handling fee.
- 5. Owner is solely responsible for the complete and accurate description of all lots including condition.
- 6. All unsold lots will be returned to the owners at the end of the sale. There is no handling fee on unsold lots.
- 7. All lots are guaranteed to the buyer by the seller to be genuine, unless otherwise noted, and as described. If expertizing becomes necessary, the buyer agrees to bear the cost if the lot is genuine and as described, otherwise the seller agrees to reimburse the buyer for the expertizing and the hammer price, if the lot is returned to the seller as purchased. NSSS will retain its 10% handling fee in any case.
- 8. Auction lots or photocopies (advised, if lot has a high value and owner would prefer to keep in his possession until date of sale) of all lots offered for sale must be sent or delivered to RUTHE DREILING, 29 East Gault Way, Sparks, Nv. 89431 no later than May 9, 1992. NSSS reserves the right to refuse to include in the sale any lots and/or photocopies which are received after this date. Photocopied lots must be delivered to RUTHE before 1:30 PM on the day of the sale.
- 9. Bids on any lots may be sent to RUTHE anytime before May 22, 1992. Bids received after midnight May 21, 1992 may be rejected at the sole discretion of the auction committee.
- 10. The size of bid incremental increases are at the sole discretion of the auctioneer.
- 11. The winning bid on any lot will be at one incremental step over the previous highest bid.
- 12. All lots sold must be completely paid for and picked up on the day of the sale. All successful mailbids from buyers not in attendance must be paid for within ten days of invoice or the lots will be returned to the owner as unsold. The buyer is free to make other arrangements with the seller but "sold" lots will not be delivered to the buyer or seller until 10% of the hammer price is paid to NSSS.
