Dear Mr. Brew;

As Exhibits Chairman of NoVaPEX, I am inviting your members to exhibit at our sixteenth annual show that will be held in Redding, March 7-8, 1998.

The big news is that we are now using sixteen-page frames which we feel will better showcase the exhibits. It will also allow you to be able to assemble your exhibit with the idea in mind of taking it to a higher level (National shows typically use sixteen-page frames) later, should you choose to do so

We are also encouraging exhibitors to begin developing a new exhibit by entering a one-frame exhibit. These exhibits will be judged as a separate category.

I am writing nearly six months in advance of our show to give exhibitors plenty of time to get that exhibit off the drawing board and onto exhibit pages. With this lead time, that is less than three pages a month.

As usual, there are no frame fees, junior exhibits of any size are eligible, and of course exhibits larger than one frame are welcome.

Consider the advantages of exhibiting at NoVaPEX:

We are a small show, usually showing 800 pages of material, thus your exhibit will not be dwarfed by the magnitude of the show. (Did anyone look at all the exhibits at Pacific 97?)

Your exhibit will be judged and critiqued by qualified judges.

There is no cost, other than the cost of getting the exhibit to NoVaPEX.
