**Elections:** Nominations are needed for President, Treasurer and one Director position. The voting will take place on **August 10** at the picnic. The Nomination Form is on page 11.



# **Book Review - "Inspector Oldfield and the Black Hand Society"**By Stan Cronwall


Just finished an interesting book about a real-life U.S. Postal Inspector entitled, "Inspector Oldfield and the Black Hand Society"

Before there was an FBI, the widest reach of any law enforcement agency was the U.S. Post Office with its postal inspectors both at home and internationally. U.S. Post Office inspectors were presidentially appointed and had the authority to take over an investigation from any law enforcement agency if the U.S. Mails were used in any fashion.

They had the authority to enlist any law enforcement agency that might help their case including local police, Secret Service, U.S. Marshals and could even hire private detectives.

The book tells a true tale of how a member of the Postal Inspector Inspection Service brought to heel the Italian Black Hand crime group. It goes back into the late 1890's and took until roughly 1909-1910 to play out,

The corruption that allowed the Black Hand to flourish ran from the lowest postal clerk to the U.S. Congress. (What else is new!)



The most important thing to remember is that the way large sums of money were transferred from one city to another, or even internationally was by U.S. Mail money orders.

Money orders were the major, and perhaps only way that the widespread cells of the Black Hand cooperated. Corruption was nearly always possible when vast sums of money extorted from the local Italian and especially the Sicilian communities were transferred from one city to another.

It all started when the organization of the Black Hand came from Sicily and took root here when the immigration system was overwhelmed by a huge influx of southern Italians and more particularly Sicilians.

The immigration authorities were buried by the sheer number of these people wanting to come to America.

Judges and others were bribed to sign off on the applications. Members of the Black Hand slipped in along with the multitudes of largely uneducated, low or unskilled laborers who found their way into jobs in mines, factories and on the railroads.

While the earliest Black Hand extortion schemes were death threats to the laborers extracting modest sums from their weekly pay, some enterprising immigrants did very well in their new country becoming quite successful and even wealthy. The Black Hand then targeted them with demands for more money threatening their lives, their families and their places of business.

The threats were always accompanied by the warning not to report anything to the local police authorities. Most Italian and Sicilian newcomers had little or no grasp of the English Language so for them it was easy to either not report the "protection money paid" or feign not understanding when queried.

And, there was genuine fear of any police authority because in their homeland those people were closely tied to the Black Hand.


On top of that, there were almost no members of law enforcement at any level who knew the Italian language to speak, read or write or understand whatever combination of broken English and Italian made up any answers to questions.

Frank Oldfield's first assignment as a U.S. Post Office inspector was in Columbus, Ohio in March 1899. His job description required that he must maintain political neutrality. This rankled Oldfield because since a teenager he was a dedicated Republican actively engaged in political campaigns. He had to resign his chairman ship of the Howard County (MD) central committee and his seat on the state committee.


This earned him reprimands from superiors and clashed from time to time with his early days as an inspector.

The first crack in the case against the Black Hand came when one man defied the various threats including death and agreed to testify against the organization. Oldfield then organized several other inspectors, law enforcement people, translators and others and worked tirelessly building the case against the Black Hand. It took several years, and a judge who would not be bullied or bribed before the case was brought.

In the end, the evidence produced by the prosecution filled seven leather bound trunks. Samples of the evidence included letters posted by members of the Black Hand.



The letter above is an example of how the Society attempted to evade the discovery of their extortion demands. The addressee of the letter is supposed to open it finding an extortion letter inside with instructions to forward the second letter to the victim.

Other letters were direct demands sent to victims. These were specially coded by the letter "O" in the word TWO filled in with red ink. These were sold by the various Post Office clerks to the known Black Hand associates or those who abetted them.

Of the 14 Black Hand members put on trial, three were granted a new trial, 10 were sentenced to terms in Leavenworth Penitentiary and the youngest aged twenty spent two years in an Elmira, NY reformatory.


The Black Hand was effectively crushed. When released after serving their time some disappeared into society at least keeping their names out of the newspapers, but one family persisted in their criminal ways and were at least active into the late 1950's and 1960's in the corrupt San Francisco political machine.

**Stan Cronwall** is a member and his collecting interests include Germany: Third Reich 1933-45 and the areas it occupied (stamps covers & cards). Uzbekistan is an independent republic and a member of the Commonwealth of Independent States. When the Soviet Union dissolved on December 26, 1991, Uzbekistan and ten former Soviet republics established the Commonwealth of Independent States. ## Report by Harvey Edwards on the Board meeting held May 11:

- The club has over \$13,000 in the bank (some of that is income from the July stamp show).
- The Board voted to approve \$300 for 2020 (sent to the business charity of their chose) to store our exhibitor frames used at the stamp show at Mike Potter's business (he retires in Dec.). He will be able to use the equipment at his work to load, transport and return the frames. This works great since the two pallets each weigh over a hundred pounds.
- The fiscal year reporting will be changed to the calendar year (instead of Aug. to July). It was extremely difficult to perform an accurate audit so close to the major income/expenses with the stamp show the end of July.
- The Secretary will file the annual state paperwork for nonprofit corporations.
- The Treasurer will file the annual tax return for nonprofits (no tax is due).
- The NSSS Bylaws will be updated to reflect the above changes.
- The Silverada Estates receives \$40 each spring for new plants around the clubhouse building. They do not charge us anything to have our meetings and social functions.

## "Clothesline" Presentation at May 25 Meeting

It's been a long time since the club used the clothesline method to have members discuss items in their collections. **Dick Dreiling** solicited items and coordinated the activity.

Six members had 10 items to discuss with two of them being too big to be on the clothesline.

**Dick Dreiling** had one-of-a-kind item. It was George Linn's first first-day-cover with a typed cachet on a "mourning cover." The interesting part is a 1957 letter from Mr. Linn describing how and why the cover was created. The topic

might be a future Post Boy article.

**Stan Cronwall** (on the right) had the largest item which was an uncut sheet of 15 Nazi Germany 1939 post card proofs that never made it into production because of the start of WWII. For reference, the (propaganda) post cards picture Nazi rallies which draw a lot of people. The 1938 Rally had at least 700,000 participants in the weeklong event. Most arrive by train either as individuals or in groups. In 1939, (entitled the Rally for Peace) the Rally was abruptly cancelled about two weeks before it would have taken place. The trains were needed to transport personnel, and armaments to the Polish border in readiness for the attack that began WW II. Thus, the post cards were never printed. Stan also "plated" a complete sheet using individual cards.



**John Walter** followed with three pages of Naval Covers he obtained at WESTPEX as he joined the Universal Ship Cancellation Society. Two covers from 1933 & 1934 had U.S. Frigate Constitution postmarks from San Diego. More recent covers were produced by the Decatur Chapter member Rich Hoffner and sent free for joining the USCS. Rich honed his cachet making skills over 35 years producing mainly naval covers on a letterpress printer. Next were two Mermaid Hand-Painted cachets by Robert Quintero and Roger Wentworth. Two of the covers are shown below.



**Tuck Vosburg** (on the right) noted an auction ad regarding a "Nebraska" collection in the *American Philatelist*. The collection was likely owned by Duane Hillmer, a loan customer of his in the 1970's. The collection was held as part of collateral for a loan. Hillmer was a successful proprietor of two printing companies and had recently purchased Scott Publishing Co. which he owned until the mid-80's.



Harvey Edwards showed two military covers (below); one from Marine Lt. D.P. Mannix (ca. 1890) and the other from Navy Cadet D. Pratt Mannix (III) (1900). Lt. Mannix was assigned to guard the body of John Wilkes Booth after the assassination of President Lincoln. He was also a "Reformer," giving new direction to the modern Marine Corp. Cadet Mannix was Lt. Mannix's son and became a Navy Rear Admiral before retiring in 1924. Admiral Mannix was also the father of famous author Daniel P. Mannix IV.

Gary Atkinson had three interesting items. One a booklet pane of 30 labeled as Scott 499f valued at \$30K. Unfortunately, it was the common Scott 499 stamp pane trimmed to look like the booklet pane. Also of interest was a Scott 94c valued at \$15K but turned out it was a fake of the 94b common stamp. The final item was a cover sent to his

wife with a Get Well card that took 2 months March 27 to May 20, 2019 to be delivered. Turns out the cover was mis-sent and postmarked on the back with the USS Gerald Ford naval cancel. This was the real keeper of the bunch.

The final item, in honor of Memorial Day, was a signed poster commemorating the battle on Iwo Jima. It was signed: "PFC Fred W. Schribert, 4th Division Marines, 3-L-25, Iwo Jima Feb. 19, 1945". On further research PFC Schribert lived in Connecticut and passed away on May 11, 2008. The following year a ceremony was held at the National Iwo Jima Memorial Park in Newington, CT which commemorates the 100 state residents lost in 1945 and 16 more were added at the ceremony. Among those added was PFC Shribert. The personal account of PFC Schribert's Marine Corp life on Iwo Jima is published in both "Men of War" and "Never in Doubt." John Walter obtained the poster at WESTPEX while meeting with members of the Universal Ship Cancellation Society.

## **Nevada Stamp Study Society**

### 2019 Nomination Form

There are three (3) elected positions open for 2019 elections. "Any member of the Nevada Stamp Study Society in good standing, who is 18 years of age or older, shall be eligible to hold any office in the Society or to serve on any committee, provided however, that a candidate for the office of **PRESIDENT** shall have previously served either as an elective officer, or as a member of the Board of Directors, or as chairman of a standing committee."

**President**: Serves for two years from August 2019 to July 2021. "shall preside at meetings of the Society and Board of Directors. Shall appoint with the approval of the Board, the various standing committees. Shall execute on behalf of and in the name of the Society, when so authorized by the Board, all contracts, deeds and other legal instruments. Shall have general supervision over all officers and standing committees, to the end that there shall be full and complete performance of their duties by each of said officers and committees. Shall, upon termination of their office, serve as a member of the Board for the period of not less than one year to assist in maintaining continuity in the affairs of the Society." (Bylaws; Article VI, Section2)

**Treasurer**: Serves for two years from August 2019 to July 2021. "Shall be responsible for the custody of all securities of the Society subject to the supervision of the Board of Directors. Shall advise the Secretary in all matters concerning the financial duties discharged and may authorize disbursements of funds on vouchers signed as above provided. Shall present to the Board annually a complete statement prepared in collaboration with the Secretary, of the assets and liabilities of the Society and of the financial transactions of the Society, accompanied by the bank statements of the amount of money and securities on deposit or held in trust at the time of such statements and any report of any official audit of the accounts. Shall collect all dues and fees, and keep proper books of account showing all receipts, disbursements and balances of cash on hand. Shall deposit all monies of the Society in a bank or banks designated by the BOARD to the credit of the Society. Shall receive all applications for membership together with all data which may be received in connection therewith. Shall have custody of the seal, keep the records of members and issue membership cards and receipts." (Bylaws; Article VI, Section5)

**Director:** (one position open): Serves for 3 years from Aug. 2019 to July 2022. "shall have supervision of such activities of the Society as may be assigned to them by the President or the Board of Directors, and shall help to promote the Society. At a minimum, a Director will supervise and report on the activities of one of the standing committees." (Bylaws; Article VI, Section 6)

A candidate for any of the elected positions may submit a short resume outlining their organizational and leadership qualities and should list any goals they may have for the Society. Any information provided by the candidate is voluntary and is not a requirement to run for office.

The slate of candidates will be published in the July issue of the Post Boy with elections taking place, by secret ballot, on August 10 (at the club picnic). All nomination forms must be returned by July 13, 2019 to George Ray.
