Greetings from The West Indies by Patrick Crosby

It is the middle of winter in 1977 and Jerry and Charley can't resist rubbing in their vacation fun in the sun to their buddy in New Jersey. They were at Club Med on the West Indies island of Martinique, an overseas region of France. The Martinique stamp below shows one of their "beautiful native girls".

Unfortunately, the two French stamps on the postcard were not acceptable. This is because by the time the card was mailed the boys were a few islands north in the city of St. Johns on Antigua. At the time Antigua

and Barbuda (the country name) was an Associated State of the United Kingdom so the French stamps had no postal validity and no postage had been paid. Antiguan stamps should have been used. Antigua and Barbuda includes the islands of Antigua and Barbuda plus the uninhabited much smaller Redonda and some other very small rock/coral islands. The Antigua stamp on the right shows the British connection not only with the portrait of Queen Elizabeth II, but also the vignette shows the former naval base Nelson's Dockyard, which is in English Bay.




The Postage Due handstamp shows 29¢ and this amount was figured using a formula first used by the United Postal Union (UPU) beginning in 1976. It doesn't require the destination country to know what currency is being used in the country of origin. A postal clerk in St. Johns, the capitol of Antiqua and Barbuda, notices the French stamps, does not deface them in any way, and postmarks the card away from the stamps. Since there is no return address (the first option is to return to writer) he then handstamps a "T" (for the French "taxe" – the official language of the UPU is French) and writes "10/20". The "10" is the shortpaid amount and the "20" is the normal UPU surface (airmail was not requested) letter rate to other UPU countries including the USA. From now on the card is postally considered to be a letter.

When the card arrived in New York City the foreign mail clerk took the "10/20" fraction (or $\frac{1}{2}$) and multiplied it by the USA's standard UPU surface letter rate to another UPU country, which was 18¢. The clerk then added a 20¢ handling charge. So (1/2 x 18¢) + 20¢= 29¢. (In mid-1981 the handling charge jumped to 42¢.)

I'm thinking Jerry and Charley heard about their bonehead postage move when they got home. But then again, they weren't really on a "cultural" vacation.

From 1967 to 1981 Antigua and Barbuda was an Associated State of the United Kingdom, then becoming an independent state in the United Kingdom's Commonwealth of

Nations. Along with some other island nations they use the East Caribbean dollar which since 1976 has been pegged to the US dollar at an exchange rate of \$1US = \$2.70EC. Martinique, where the Club Med is located, now uses the Euro.

Kenneth A. Wood in his stamp collecting encyclopedia *This Is Philately* has some interesting tidbits from the philatelic point of view. Although Antiguan stamps are considered legitimate, only the 1922 issues of Barbuda are considered legitimate by Scott catalogue. A set of 11 Leeward Island stamps (as the one shown) were overprinted "BAR-BUDA". Stanley Gibbons catalogue does include later issues. Ken Wood mentions Barbuda's "…chief local occupations are fishing, smuggling, and farming". The barren, uninhabited Redonda (once mined for phosphate) also has postal issues, but no one considers them to be legitimate. Here is the rub – the stamps of both Redonda and Barbuda, some being overprints on Antiguan stamps, are valid for use in Antigua.



Although the island of Antigua, where most citizens live, was spared a direct hit from Hurricane Irma in September 2017, the smaller island of Barbuda 25 miles north was not. It was in the eyewall of the Category 5 hurricane at its near peak intensity. With nearly 95% of its structures damaged or destroyed by flattening or flooding (including the only two hotels), the island was virtually uninhabitable and the citizens were evacuated to Antigua. Now reconstruction is underway, but recent photos from Google Maps still show extensive destruction and very few inhabitants in Codrington, Barbuda's only town. However, when viewed from the skies the islands of Antiqua and Barbuda are gems.

Hawaii Fumigated Cover By Howard Kadohiro

Coronavirus pandemic!! My daughter has my wife and me under "house arrest." We are forbidden to leave the house and she checks on us daily. Wash your hands, use hand sanitizers, and wipe down all surfaces with disinfectant wipes. Wear gloves when getting our mail and disinfect them before opening. We live in extreme times.

Disinfect mail before opening? Reminded me of a fumigated Hawaiian cover I bought over 20 years ago. There were ten times from 1853 to 1900 that epidemics in Hawaii, Asia, and San Francisco resulted in mail being fumigated before delivery in Hawaii or shipping to foreign destination.

Almost all fumigated covers are from the 1895 Cholera Epidemic and 1899-1900 Bubonic Plaque Epidemic. Fumigated covers have the telltale signs of two or more clipped corners and postmarked during the quarantined dates.

Honolulu was quarantined from August 20, 1895 to October 23, 1895 during the Cholera Epidemic of 1895. "Mail was fumigated before it could be put aboard a ship bound for another port."

Quarantine dates for the 1899-1900 Bubonic Plague Epidemic were December 12, 1899 to April 30, 1900. The cover shown is from this period. It was posted in Honolulu on March 5, 1900 addressed to Hoosick Falls, N. Y. and has two bottom corners clipped.



Address side of cover postmarked Honolulu, HI, March 5, 1900 to New York. Reverse side of cover with transit postmark March 13, 1900 and receiving postmark in Hoosick Falls, NY on March 19, 1900. Notice the clipped corners.

Closed Album - Gary Dahlke 1938-2020 By Paul Glass

Gary Lee Dahlke, age 81, passed away in the loving care of his family on March 23, 2020, at the Norlite Nursing Center, Marquette, MI.

Born May 21, 1938, in Rice Lake, Wisconsin, the family moved to Marquette in 1946. His schooling included Northern Michigan University with continued studies at Western Michigan University from where he earned his bachelor's degree in Marketing. Upon receiving his degree, Gary returned home to work in the family U-Haul dealership and oil company. With the retirement of his father, uncle, and cousin, Gary assumed ownership of the dealership and oil company in the late 1970's, a business he successfully operated until his own retirement in 2004.

Gary began collecting around age 10 or 11 and started collecting stamps and Indian Head coins. He later began an interest in genealogy. Those remained his prime interests - stamps, coins and genealogy.

He and Rose Moratti became a couple some years after their respective spouses passed away. They both grew up and lived in Marquette, Michigan. Later, Rose's husband came to Reno to work and Rose had a home in Sparks. For the last 10 years or so, Gary and Rose would spend the summers in Michigan, fall & spring at Rose's home in Wingfield Springs in Sparks and winters in Mesa, Arizona.

Gary and Rose joined the NSSS about 10 years ago and faithfully attended the club's annual Christmas party. Gary enjoyed collecting recent USPS issues and selling his excess stamps at our stamp club meetings. His major collecting interests were U.S., Canada, and Germany.

As you know, when he was in town, he participated actively in our club meetings. Both he and Rose were members of our club. He often offered current U.S. stamps to our members at face value. Gary was well-known at the Post Office in Marquette as he and Rose would annually make biscotti cookies during the holidays and ship numerous parcels of them to family and friends using multiple stamps on the packages. Gary told me that one time the post office clerk in Marquette saw a package that had 40 to 50 stamps on it, started to count the many small postage stamps, and finally Gary assured the clerk that he had the right amount of postage and the clerk took his word for it!

Gary always had a positive outlook on life, even while he struggled with stomach cancer these last two years. I had talked to him several weeks ago on the phone and he was still looking to return to Sparks this summer.

Throughout the years, Gary kept actively involved in the community, giving back whenever possible. In his leisure, he enjoyed time spent with family, coin collecting, genealogy, and stamp collecting. He was a member of the American Numismatic Association, Commemorative Air Force Association, American Philatelic Society, Nevada Stamp Study Society, Palatines to America, Marquette County Genealogy Society, and Marquette Range Engineers.

Gary is survived by 4 sons, 2 daughters, 25 grandchildren, 16 great-grandchildren and his special friend and significant other, Rose A. Moratti.
