Regular club meetings in June:

June 13 and June 27 - Both meetings will be virtual using the Zoom app. Instruction to log into the meetings will be sent a few days before each meeting.

George Ray checked with Silverada Estates about physical meetings. June 1 they will start allowing small groups, up to 10 people, to meet. All the normal precautions will be adhered to with facial covering, social distancing, hand sanitizer, etc. The club normally has three times that many attending a meeting, so impossible for person-to-person meetings until further notice.

2020 Greater Reno Stamp & Cover Show Canceled

"Good news travels fast; bad news travels faster"

Hello fellow NSSS members:

As you are all aware, our lives and daily activities have been upended by COVID-19. We are making less trips to the store and having to be creative to keep in contact with our children, grandchildren and friends.

The club has moved its meetings, for the time being, to the web using Zoom. At each meeting we have talked about the annual stamp show but at the May 23rd meeting we reached the point where we had to vote on whether to go forward or cancel the show scheduled for July 25-July 26 at the National Bowling Stadium. I think most everyone in attendance would really have preferred to go forward but, regretfully, we determined that we had little choice but to cancel the show.


Some things were within our ability to address but many of the obstacles were not. Nevada is currently in "Phase 1" of reopening with the governor expected to speak this evening (May 26th) about moving into Phase 2, potentially next week at the end of May. The Bowling Stadium would be a "Phase 3" reopening. "Large" gatherings would be allowed in Phase 4. I have not heard any discussions about target dates for Phases 3 or 4.

In talking with the Stadium manager, he hadn't received any specific directions for reopening. They anticipate that the museum (our show room) occupancy will be halved. We revised the show room layout to a less dense layout that accommodates only 8 dealers and the post office (down from 13 dealers and the post office) and we had commitments from 8 dealers to fill those tables. However, we do not know if the bowling stadium would have been open for the show. Nor do we know if the city would have let us go forward with the show, what kind of mitigation plan they would require of us or how onerous it might be.

We also don't know if our revised layout would have been acceptable to the City but if it were, physical distancing would have required us to monitor and limit the number of people in the show room and the number of customers at any dealer booth throughout the show. We would also have had to manage attendees waiting to come into the show.

There was a concern that many of our members are in the at-risk category and we might be taking on a liability if an outbreak was traced back to the show. We were also concerned about setting up sanitizing stations, providing any required PPE (face masks) and signage requirements. Some other concerns were how to determine/monitor the wellness of attendees, whether we could or would enforce wearing masks, and who would enforce physical distancing and the wearing of masks.

We hope that you agree, or at least understand, our reasoning for canceling this year's show.

Post Boy Reporter

May 9 virtual meeting - Harvey Edwards conducted the meeting via Zoom with 13 attendees. Members with any type of Internet connection can attend, even using your smart phone. Instructions on connecting to the video conference are emailed before each meeting. The Zoom meeting was a big hit and well received!

Announcements: A volunteer is still needed as Program Chair to coordinate philatelic presentations at meetings. **Erik Fields** and **Harvey Edwards** led a lengthy discussion about the July 25-26 Reno Stamp Show including a possible need to cancel/postpone the event. Discussed were a variety of things such as advertising post cards mailing deadline, and deadline for placing announcements in Linn's. Also discussed were security, and what measures will be necessary for sanitation, and how to plan for "walk -ins," including the homeless. Dealers are still eager to attend. There would be little or no competition from other philatelic activities, because most others are now canceled. It was agreed to postpose final decision to the May 23rd meeting. Harvey will contact the supervisor at the venue which is still closed for their input; all Artown activities with groups of people are canceled in July; still lots of uncertainties.

The Dreiling Award nomination form has a link on the website homepage. **John Walter** reported on the website (updated after each meeting) and the Post Boy newsletter which has several members submitting articles.

Robert Martin reported from paradise (lives in Hawaii). He has the same Stay at Home guidelines as NV PLUS a 14 day quarantine for folks coming to the island. His school program Stamp Club for Kids is on hold since all the schools are closed. He normally has 250 to 300 students join the stamp club every **year**. On a weekly basis he will normally have anywhere from 50 to 80 attend. The school library only has chairs and tables for 70 at a time. He normally takes the club in three shifts, so rarely is the library overloaded, but it has happened. In those situations, the extra kids are happy to just sit on the floor. There are extra tongs, bowls of stamps, and bowls of hinges to accommodate any overloads.

Also discussed was the situation with the USPS being financially strapped.

May 23 virtual meeting - A few members had a problem setting up their Zoom connection but, 19 members attended. Another rewarding virtual meeting. It is always great seeing everyone.

Harvey Edwards worked hard on two Show cover cancels - passage of the 19th Amendment to the Constitution and the 150th Anniversary of the Carson Mint. The club might be able to use them as a small fund raiser to offset some of the stamp costs for this year. The club spent about \$250 for show advertising post cards.

Eric Fields is picking up the club mail on a regular basis from the post office box.

Robert Martin discussed his perfin collection and still adding items - now over 10,000.

Incline Village is the First Day city for the upcoming Great Outdoors stamp issue on June 13. No official ceremony is planned but First Day Covers can be purchased through the USPS Fulfillment Center.

Three new upright Jenny panes have been found from purchases through the USPS Fulfillment Center. The club still has about a dozen unopened panes that are raffled at meetings. The club raffled three of the panes before the stay-at-home guidelines. Unfortunately, no upright Jenny panes were found.

The national APS, AFDCS, ATA Joint Great American Stamp Show is canceled for Aug. 20-23 in Hartford, CT.

(from Linn's, June 1): Is Iceland becoming a dead country for collecting stamps? Announcement that no new Icelandic stamps will be issued after Oct. 29, although Iceland Post "will probably reprint older stamps in order to have sufficient stamps for senders." The USPS Board of Governors selected Louis DeJoy as the next postmaster general. He is a North Carolina business executive without any Postal Service experience. No more customized postage from Stamps.com after June 16. For 16 years individuals and businesses applied for custom made postage with family, pets and business logos known as Photostamps. The USPS ended the contract.

"They Were Expendable" by Howard Kadohiro

In an interview with a representative of the New York City Transit Authority (NYCTA), the reporter seemed intent of excoriating the manager for not providing adequate number of train cars, and buses to prevent over-crowding. The NYCTA had cut service and did not shut down to provide transportation for essential workers. Why did the NYCTA not put additional cars into service to prevent overcrowding? Her answer revealed how inadequately NYCTA was prepared for Covid-19. Transit workers were not provided with any PPE early on and when some workers showed up with masks, they were ordered to remove them because the mask will frighten commuters and they should only be for hospital workers and first responders. The MTA spokesperson's response was stunning. Because transit workers were not provided PPE the coronavirus had decimated their ranks, sickening thousands and killing many that the number of buses and train/subway cars was all that the MTA could provide. The Health of the NYCTA workers were sacrificed to protect the frontline hospital workers.

Using the analogy that the effort to defeat the Covid-19 virus is a war, at the beginning of WW2 the United States Armed Forces Far East, USAFFE, were ordered to defend the Philippines and never surrender to the Japanese with the promise of reinforcement of men, equipment, and supplies. These were empty promises. The leadership at the War Department had no intention of sending reinforcements to the Philippines. Yet they ordered the ASAFFE to hold on and keep fighting until aid arrived.

The focus of the War Department was on defeating the Axis powers in Europe. The abandonment of the USAFFE in the Philippines led to the largest surrender US armed forces personnel in history.

Like essential workers today, the Bataan Death March survivors were not forgotten, and support continued through the war. At the end of WW2 veterans were given financial, education and health benefits under the G.l. Bill. How will history record how essential workers (hospital, transit, truckers, farmers, food processors, supermarket clerks) were treated? Will we provide aid to mitigate the cost of medical care from exposure to the virus, and other financial aid, or

will we just pat them on the back, tell them what a great job they did, give them a pink slip and tell them they're on their own to deal with the effects of the virus?

San Francisco Mail after the 1906 earthquake By Emmanuel GPS

At 5:12 a.m. on April 18, 1906, an earthquake devastated San Francisco, California, and shook nearly the entire west coast of the United States. The earthquake and fires caused hundreds of deaths and millions of dollars in losses. Fortunately, the gorgeous United States post office at 7th and Mission, opened in 1905, survived.

As an emergency measure, mail without stamps was accepted until the sale of stamps was possible at the main post office on April 25. Mail was postmarked in San Francisco and sent to the receiving post office, where postage due was assessed, postage due stamps affixed, and the fee collected from the recipient of the letter.

The small cover featured here was postmarked in San Francisco on April 24, 1906 at 2pm. It arrived in San Leandro, California at 7:30am, where the recipient paid 4¢ postage due. On the back the postal clerk applied two 2¢ postage due stamps with hand-cancel "Rec'd April 26, 1906."

Postage stamp sales resumed in San Francisco on April 25, only a week after the disaster struck. Rapid resumption of postal services sent a powerful message to the country and world: San Francisco might be laid low, but its heart —its business and personal relationships —still beat.

I've been wondering for a while how catalog value for Hawaii stamps were trending. Scott Matthews had a copy of Scott 2020 US Specialized and I had the 2019 volume. With Scott's help I began tracking about 500 Hawaii values starting from Scott number 1 thru R16. Mainly unused, used, unused non-hinged, and on cover. It resulted in changes in 16 values, 13 increases and 3 decreases. Largest dollar increase was in Scott No. 19 unused in single and pair, \$25.00. Largest % increase UX4 unused, 10%. Largest dollar decrease was Scott No. 1 unused, \$35,000.00. Largest % decrease was No. 20 on cover, 7.9%.

It took some time to enter all the values, but thanks to the coronavirus I had all the time to complete this project. Volume 1 of 2021 Scott Standard Catalog is out, so this information is dated, but still interesting.
