Due to the increased positivity rate (over 12%) for COIVD-19 in the local area, both in-person meetings were suspended in October.

Oct. 9 meeting – The Zoom meeting had 13 members attend. Announcements included: **James Steckley** has 15+ donated lots that will be in this month's online auction; **Erik Fields** and **Harvey Edwards** has the 2022 Greater Reno Stamp & Cover Show venue reserved for July 23-24 at the National Bowling Stadium Museum and possible themes for the stamp show were mentioned; the Penny Boxes with foreign stamps are being organized by **Jeanne Paquin**; SACAPEX (Sacramento Stamp Show) is scheduled for Nov. 6-7.

Dave Parsons reported online Auction #13 will start Oct. 12 and new sellers are needed.

The raffle drawing for an unopened pane of the 2013 Inverted Jenny stamp (face value \$12) was won by **Howard Kadohiro**.

A **board meeting** followed with 7 members present. **Erik Fields** reported the club has \$12,364 in the bank. Motion was made and passed to reimburse **Dave Parsons** for use of his personal Zoom account over the past 18 months. Money was also approved for \$85 to update the club laptop computer with a Bluetooth dongle and memory upgrade. Exhibit frame fees were discussed for the July stamp show. Committee reports were received from: Donations, Webmaster, Post Boy editor, Programs, Online Auctions, Penny Boxes, Auction Bucks, and Membership (74 members).

Oct. 23 meeting – The Zoom attendance was 17 members plus Heidi Clark, Postmaster Vista Post Office, Sparks. **James Steckley** reminded everyone this is the 38th consecutive meeting via Zoom.

Dave Parsons reported on the Oct. Online Auction – There were a total of 96 lots with 74 sold (77%) with \$489.60 in gross sales. Online Auction #14 will start Nov. 16 and end Nov. 24 at noon.

The Christmas party signup list will be at the next two November meetings. A volunteer is needed to coordinate the pot-luck food items

and cooking of the Turkey and Ham. **Jeanne Paquin** volunteered after the meeting to serve but she needs help.

Heidi Clark, Postmaster Vista Post Office, Sparks had an open forum discussion on any post office issues. The club has two large display cases available at the Vista PO. Mail delivery issues were explained concerning extending the delivery out 1-2 days. Obliterating postmarks using magic markers and pens especially over high denomination stamps already postmarked was addressed. She would like to know when that happens from mail at Vista PO since use of markers is not the policy. Central mail processing includes all mail from Elko to Susanville comes to Vassar PO processing then sent back to be delivered. Mail delivery notification app via email will notify customer of delivery.

When a tracking bar code is applied that item will be scanned up to 13 times before delivery. The Vista PO receives at least 3 truckloads of packages from Amazon from midnight to 6 a.m. for the "last mile delivery." That involves about 2,500 packages per day. FedEx and UPS usually have at least one truckload for that last mile delivery.

The Mail Recovery Center (Dead Letter Office) function was discussed. Also, some duties of the Postal Inspectors and enforcement issues were mentioned. Sounds like any one of these topics could be a program by itself.



HONORING VIETNAM VETERANS

"That Day I Will Never Forget" By Patrick Crosby

On the "eleventh hour of the eleventh day of the eleventh month" in 1918 a ceasefire was declared to end the hostilities of World War I. The formal end to the war with Germany was June 28, 1919 with the signing of the Treaty of Versailles. But on that November day people filled the streets of Paris as in other Allied Powers cities (like New York City) in celebration. On both sides of the conflict there were over 17.6 million deaths, over 43% of which were civilians. France alone lost over 1.4 million soldiers, about 4% of their population, and areas were heavily damaged or destroyed.



Caught up in the excitement of the day was U.S. Army Corporal F.M.G. and when he returned to where he was stationed in the French seaport city of La Rochelle he wrote:

Arrived back here La Rochelle last evening ending my furlough. Suppose you all got the good news. Where do you think I got the news Well in <u>Paris</u>. I got there at 8am and left at 11 P.M. That day I will never forget.

Corporal F.M.G. chose a picture postcard (right) of the Place de la Republique, a square in Paris which features a 31' bronze statue of Marianne, considered the personification of the French Republic. She is holding an olive branch in her right hand. Below her are three statues that represent liberty, equality, and fraternity. At the base is a lion guarding a ballot box.

After the corporal's message was written it was read and approved by a U.S. Army censor (appears to be T.J. Snow with the army engineers) and a typical "A.E.F. Passed As Censored" double ring circle handstamp with eagle was applied, which is indistinct on this card. The card was put into the military mail system and a postmark for November 15, 1918 from APO (Army Post Office) 735 was applied which also reads "U.S. Military Post Office MPES" (MPES = Military Postal Express Service). No postage was necessary since letters and cards mailed between the U.S., its possessions, and the American Expeditionary Forces at this time were allowed free of postage. Corporal F.M.G. should have

included his name and organization in the upper left, but the U.S. Post Office Department didn't mind minor infractions by our service personnel. When the card arrived in the U.S. a machine postmark was applied whose circle date stamp reads "Rec'd From Army, Bordeaux, Nov 20 1918". Bordeaux is the regional capital of the area in France which includes La Rochelle.

Today large gatherings are suspect because of Covid. The 1918 influenza pandemic was in full swing in November of that year. As is today, there were safety precautions circulated to prevent the spread of this flu, and I hope those who were celebrating were careful. One of the reasons Germany determined their chances of victory were poor in the end was because so many of their soldiers were unavailable and dying from this flu.

Also, not to be forgotten are all our veterans who have served and preserve our country. Thank you! On the first anniversary of Armistice Day, November 11, 1919, President Woodrow Wilson eulogizing fallen Allied soldiers wrote in part:

Out of this victory there arose new possibilities of political freedom and economic concert. The war showed us the strength of great nations acting together for high purposes, and the victory of arms foretells the enduring conquests which can be made in peace when nations act justly and in furtherance of the common interests of men.

In 1938 Armistice Day, November 11th, became a federal holiday in the United States dedicated to the cause of world peace. In 1954, 9 years after a World War II veteran Raymond Weeks from Alabama started promoting the idea of including all veterans on this day, Armistice Day was renamed Veterans Day intending to honor all members of our armed forces either living or dead.

November Quiz - Private Posts Around the World By Eric Moody

- 1. After establishing a national postal service in 1871, this European country permitted local private mail companies to issue their own stamps and operate within the boundaries of their cities or towns. These private companies, which primarily delivered circulars and other printed matter, continued to exist in numerous communities until 1900, when local mail delivery was assumed by the country's national postal system. This country is:

- 2. In 1895 the Oceanic Phosphate Company, which was mining guano on this small Pacific island now claimed by France, issued a set of postage stamps that illustrated various features of the island.
