#### **Meetings** -

**Greater Reno Stamp and Cover Show** – July 29-30. The Exhibitor Prospectus is attached on pages 9-10. Notice that there is no frame fee for your exhibit. Just a reminder that each exhibit frame can accommodate 16 pages if they are the standard 8½ x 11 inches.

If 16 pages sound intimidating, there are also frames for a single "My Favorite Thing" page. You can have as many of your favorite pages as will fit in allotted frames. Favorite pages are also displayed in the National Bowling Stadium lobby and the registration desk area.

With the sesquicentennial of the first U.S. postal card this month, have a look at some examples of the postal card starting on page 3.

Page 5 is a short article of some WESTPEX purchases by **John Walter**. I hope members will tell about their recent purchases at a future club presentation.

### **Post Boy Reporter**

**April 8 meeting –** The attendance was 22 members including 3 members via Zoom. There were also 2 visitors, Jerry Barrett and his friend, Judith. Both participated in the live auction. **Erik Fields** and **James Steckley** arrived early to set up the meeting room. **James Steckley** provided the refreshments.

**James Steckley** had a few donations and talked about upcoming new postal issues. The Sparks Heritage Museum donated various microphones with floor stand, a wireless mic and an old projector that lacked good resolution. The microphones were used at the meeting.

**Erik Fields** reminded members about the Greater Reno Stamp & Cover Show, July 29-30. The show post cards are printed, and copies will be distributed at WESTPEX (April 28-30) and mailed in early July. Three dealers are confirmed with payment with more on the list for participation. Exhibits are being solicited.

**John Walter** reported on the new display at the Vassar post office, the Post Boy articles and The Wild West quiz in the newsletter. He also discussed his process for selling his substantial P.R. China collection to a NY dealer who came to his home last May. This was after talking with various auction houses at last year's WESTPEX. John is accepting Nominations for the club election in August. The open positions will be president, treasurer, and two directors. See John for a nomination form.

The raffle was conducted by **Betty Mudge** with 10 prizes and a bonus prize won by **Howard Grenzebach**. The money of \$7.00 was won by **Gary Atkinson**.

The live auction had 44 member lots plus 8 donation lots with 35 lots selling for \$234.50. **Gary Atkinson** was the auctioneer with **Nadiah Beekun** helping.

At the Board meeting a decision was made to purchase the Acer projector that **John Walter** has provided the last few years for club meetings. The club paid \$100. **Erik Fields** reported about \$11,000 in the bank. Recent invoices were \$1,056 for the storage unit, \$509 for liability insurance (covers meeting facility and the show venue), \$256 for the show post cards, and \$15 Council dues.

**April 22 meeting – Erik Fields** and **James Steckley** arrived early to setup the tables and chairs. Refreshments were provided by **Kevin Morris**. Attendance was 17 members.

**James Steckley** discussed the new postal stamps for May: Tomie dePaola (single forever), Chief Standing Bear (single forever), and Endangered Species (20 designs forever). Linn's stamp poll results were discussed. Donated stamp albums were on display and will be in the May 13 meeting auction.

**Erik Fields** gave a report on the stamp show: 8 dealers are confirmed, the Exhibitor Prospectus is available, APS mailing labels were received plus about 400 more labels will be printed from past attendees.



The raffle was conducted by **Betty Mudge** with 10 prizes. The bonus prize was won by **Howard Grenzebach** and the money prize of \$5.00 went to **Erik Fields**.

Presentation on "GE Postal Cards" was given by **David Gehringer**. These were advertising privately printed on UX38 postal cards and rare UX47 overprinted postal cards. Excellent presentations with Dave's collection of 8 cards shown.

# First U.S. Postal Card Sesquicentennial By John Walter

This month marks the 150<sup>th</sup> anniversary of the issuance of the "Lady Liberty" postal card (UX1).


The penny postal card was first put on sale May 12, 1873, in Springfield, MA, and in other cities a day later. The New York Times of May 14, 1873, noted that the cards "at about 11 o'clock were given to the clerks at the stamp windows for sale.


... The result was something unprecedented and proved that the new cards are destined to meet with public favor. Although the arrival of the cards was not generally known, still between eleven o'clock and one and a half, over 200,000 were disposed of, a number definitely larger than the most sanguine advocates of the new system expected."



There is a wonderful 6-page article in the April issue of the *American Philatelist* that explains the history, has excellent illustration of the large and small watermarks and other facts about the card.

Here are images of the **first issue** from my mounted postal card collection.









Card addressed to Sydenham College, England. No postmark. Short message on back "New York, 10<sup>th</sup> June 1873, With Papa's kind love."

No evidence card was sent since Great Britain Treaty letter rate per  $\frac{1}{2}$  oz. was 6¢. (1 Jan 1870 - 30 Jun 1975).




Card sent from Chauncey, Ohio to Newville, Cumberland County, PA. The postmark is July 31, the year unknown. Bulls-eye cancel on the indicia.

The message on the back does not have a date and is asking "Please forward letter addressed to Wm. B. Maccracken to a New York address."

Here are some images from the **second issue** with small watermark issued in June 1873.



1¢ Liberty, brown on dark buff. Size: 130 x 76 mm. First Day of Issue: Unknown Quantity Issued: 207,851,700. Small watermark as below.



Small watermark of USPOD. Actual size: 55x38mm.



The small watermark is visible without further illumination.





Front and back of card mailed Nov. 25, 1873.

# 2023 WESTPEX By John Walter


One of the largest stamp shows on the west coast (65 dealers and about 265 exhibit frames) ended on April 30. At least five members of our local stamp club attended. I attended the Ryukyu Philatelic Specialist Society (member) meeting with a discussion on conservation for early Ryukyu postal history items. Interesting that one can purchase an early cover for \$20 and spent a couple of hundred dollars to remove tape marks and other acid destroying marks to increase the value; but does that cover the conservation cost? Sometimes!

The Collectors Club sponsored two seminars including the one I attended on "Constructing an Award-Winning One Frame Exhibit on a Budget." I hope to put that information to use for a future exhibit. A great history lesson on the "VJ Day in Tokyo Bay" was presented by Steve Shay from the Saginaw Chapter of the Universal Ship Cancellation Society (member) showing covers canceled on Sept. 2, 1945, from 58 of the 255 ships present around the Tokyo Bay area.

**Dave Gehringer** and I represented our club at the meeting of the Northern California Council of Philatelic Societies since our club is a member.

As with the last few WETSPEX shows I like to show-and-tell a few items I purchased. This year I found a few inexpensive aerogrammes addressed to overseas destinations. The first one was found in a dollar box of covers. It was mailed by a USAF TSGT., APO New York 09179 (RAF Lakenheath, UK) to Dundee, Angus, Scotland using an aerogram canceled on the U.S. Coast Guard Cutter *Staten Island*, WAGB-278.

Research on the USCGC *Staten Island* revealed it was a Wind-class icebreaker commissioned in 1944 and almost immediately transferred



to the Soviet Union (named *Severny Veter*) under the WWII lend lease program. The vessel was returned to the U.S. in 1951 and in 1952 was renamed the *Staten Island*. She was involved in many icebreaking voyages first in Antarctic then in the Arctic based in Seattle.

As you can see by the cachet, in 1971 she was part of Operation DeepFreeze in the Arctic. She was decommissioned in 1974.

The second aerogram was a personal letter from Norene Card in Midland, MI to a couple in West Germany mailed June 12, 1971.

I also purchased two other aerogrammes addressed to Italy in 1971 and Moscow, U.S.S.R. also in 1971. These aerogrammes will be shown at a future club presentation.

### Greater Reno Stamp & Cover Show July 29-30, 2023 EXHIBITION PROSPECTUS

#### **RULES AND REGULATIONS**

- 1. This is an open show. This Exhibition is open to any collector, regardless of society affiliations, to exhibit his/her own material providing the entry meets the requirements of this prospectus. All work on the exhibit must be the work of the exhibitor.
- 2. Each entry must give the TITLE of the exhibit and a brief description not to exceed 30 words. Exhibitors should include a copy of the title page, plan and an exhibit synopsis. The entry form may be reproduced to obtain additional copies. Entries received after July 1 but prior to July 24 may be accepted.
- 3. Exhibits must not show marks of identification of ownership on the face of pages or sheets being exhibited. If the exhibit contains covers, the exhibitor must cover his/her name and address so that it is not visible.
- 4. Each exhibitor must file with the Exhibition Committee a signed entry form, which is attached, signifying acceptance of these rules and regulations. No entries will be accepted after July 20, 2023.
- 5. Exhibits will be limited to a minimum of one frame and a maximum of ten frames. All exhibits must be in sheet protectors and mounted on individual pages to fit frames holding **sixteen** 8  $\frac{1}{2}$  X 11 inch pages in 4 rows of 4 each or **twelve** pages of 11 X 11 inches placed in four rows of three each.
- 6. **No** entry fee will be charged.
- 7. In the event the exhibition is oversubscribed, the Exhibition Committee reserves the right to allocate frames or reject any exhibit in whole.
- 8. **Exhibitors must provide their own insurance.** The Nevada Stamp Study Society will provide all reasonable care and security for exhibits received. The Nevada Stamp Study Society will provide uniformed security during all the hours the show is open and during all the hours the show is closed. However, the Nevada Stamp Study Society is not responsible for any loss due to theft or any other cause. The Exhibitor agrees not to hold the Nevada Stamp Study Society responsible for any liability or claim for personal injury, property damage, or loss.
- 9. **Do not ship exhibit** with entry form. You will be notified, in writing, when and where to ship your exhibit. Exhibitors may hand carry their exhibits to the show. No exhibits will be removed from the exhibition frames until after the show has closed at 4:00 p.m. July 30, 2023.
- 10. **Award** Grand awards for best single frame and multi-frame exhibits, and best Junior Award. Gold, vermeil, silver and bronze ribbons will also be awarded. The show attendees will vote for the People's Choice Award to be announced on Sunday afternoon, July 30, 2023.
